

# Flare Product License Agreement

This is a legal agreement between you (the Customer) and ORIGO Education (the Licensor) that provides the terms and conditions of this non-exclusive License and the limited Warranty for this Product. Using the Product indicates an acknowledgement that you have read and agreed to be bound by the terms and conditions of this Agreement. If you do not agree to these terms and conditions, return the Product to the place of purchase (see contact details below) within 15 days of the date of purchase (with proof of purchase) for a full refund.

## 1. License Grant

You do not receive title to the Product. Copyright of the Product (which includes all images and text incorporated in the Product, and any accompanying materials) is owned by the Licensor and/or its suppliers and is protected by international copyright laws. ### You may
