I understand that traveling internationally may be hazardous and involve the risk of injury, sickness, and possibly death, as well as property damage, when traveling to and from and/or within these international destinations. I understand that I may need to travel and live in very rural areas, risk violence from crime, war, terrorism, political unrest and other dangers, and may be exposed to food and water-borne diseases and to disease from other carriers or while traveling internationally. I understand that some diseases may not produce symptoms during the actual Trip, but may occur after the trip. I understand also that medical facilities abroad may not be of the quality of medical facilities in the United States/ Australia.

I acknowledge that I am in good physical condition, and that the journey may involve physical activity including but not limited to long walks and hiking in hills and/or mountainous areas.

I understand and acknowledge that while ORIGO Education and Teachers2Teachers Global may take reasonable steps to insure my safety during travel and while participating in ORIGO Education and Teachers2Teachers Global activities, these precautions are made in good faith and do not warrant acceptance of liability or guarantee that actions undertaken will demonstrate and/or constitute non-negligent performance therein by the organization, its agents or assignees.

I acknowledge that I will participate in activities and events while on the Trip facilitated by ORIGO Education and Teachers2Teachers Global, its directors, officers, employees, volunteers, interns, or agents. I acknowledge that ORIGO Education and Teachers2Teachers Global do not have control over third parties and will not hold it liable for third party actions. I acknowledge that, as a participant, my actions reflect upon ORIGO Education and Teachers2Teachers Global. Therefore, I agree that I shall behave in an appropriate manner and shall exercise reasonable care in participating in order to avoid damaging the reputation of or risking the assessment of liability against ORIGO Education and Teachers2Teachers Global. I will make an effort to research in advance how my behavior might be objectionable in a different culture.

I, individually and on behalf of my heirs and assigns, warrant, agree, and understand that I am volunteering for a nonprofit organization and therefore shall not perform any services for ORIGO Education and Teachers2Teachers Global for which I expect or desire to receive compensation of any kind during my participation. I, individually and on behalf of my heirs and assigns, specifically disclaim any claim to any compensation of any kind from ORIGO Education nor Teachers2Teachers Global as a participant.

I, individually and on behalf of my heirs and assigns, release and agree to hold ORIGO Education and Teachers2Teachers Global, their directors, officers, employees, volunteers, interns, or agents harmless from all liability for harm to myself or my personal property,



resulting directly or indirectly from my participation in the Trip or its activities and events. Such liability includes but is not limited to liability for harm to myself or my personal property resulting from ORIGO Education and Teachers2Teachers Global's negligence or from illness, disease, civil unrest, war, terrorism or transportation accident or failure. I personally assume all risks and liabilities in connection with my participation in the Trip and agree to indemnify ORIGO Education and Teachers2Teachers Global against any liability which might be assessed against it as a direct or indirect result of my participation.

I acknowledge that travel to certain destinations requires vaccinations. I agree to obtain any needed vaccinations and acknowledge that ORIGO Education and Teachers2Teachers Global have no duty to ensure that I do so. I will not hold ORIGO Education or Teachers2Teachers liable for harm that results from either obtaining the vaccinations or failing to obtain them. I understand that vaccinations do not guarantee immunity against infection.

I understand that hospital facilities, qualified medical care, and emergency medical evaluation may be limited or unavailable during portions of the Trip. In the event of my injury or medical emergency during the Trip or its activities and I am unavailable to authorize medical treatment, I authorize dental, medical, or surgical treatment and/or evacuation, including but not limited to the administration of X-rays, anesthetic, or anesthesia, by any medical professional chosen by ORIGO Education and Teachers2Teachers Global. I understand and agree that this consent is given to encourage ORIGO Education and Teachers2Teachers Global and the medical professional to exercise their best judgment as to such diagnosis or medical, dental, or surgical treatment/evacuation. I personally assume the duty of payment of any medical professional, hospital, clinic, ambulance and evacuation service, and release ORIGO Education and Teachers2Teachers Global from any such duty of payment.

I understand that transportation may be provided by ORIGO Education and Teachers2Teachers Global to and from the Trip's destinations and activities and agree that I will be able and willing to participate in such transportation. I consent to participate in said transportation and agree to release and hold harmless ORIGO Education and Teachers2Teachers Global from any and all liability. I understand that the severity of allergies or dietary restrictions may not be understood in some communities where ORIGO Education and Teachers2Teachers Global operate, and that ORIGO Education and Teachers2Teachers Global is not liable for any dietary restrictions during travel.

I affirm that the personal information I have provided to ORIGO Education and Teachers2Teachers Global is truthful and accurate. If ORIGO Education and Teachers2Teachers Global discover that I have falsified any information, I understand that I may be removed from the Trip. Furthermore, ORIGO Education and Teachers2Teachers Global have the right to disclose the falsification for the sake of honesty, accuracy, and integrity.

Should there be any dispute regarding this release, I agree to submit to jurisdiction in Orange County, North Carolina.
